For foreign residents

As a general rule, **foreign nationals** are excluded.
However, the following cases
may be eligible for exception.

Eligibility

01.

Foreign nationals holding **permanent residency (F-5)**, **marriage immigrants (F-6)**, or **recognized refugees (F-2-4)** who are **National Health Insurance contributors**, **dependents**, or **beneficiaries of Medical Aid**

02.

Foreign nationals **who are listed in a resident registration record that includes at least one Korean citizen**, and who are enrolled in the same **National Health Insurance as a contributor or dependent**, or are **beneficiaries of medical aid**

If an appeal is submitted through the **e-People portal** (online) or at a **local community service center** (offline) under the following circumstances, the foreign nationals may become eligible for the payment.

Eligibility for Appeal

01.

Foreign nationals who are not “listed on a Resident Registration Record,” but have a “family relationship under the Civil Act with at least one Korean national” and are enrolled in National Health Insurance as contributors or dependents, or are beneficiaries of Medical Aid

02.

Those who acquired eligibility for the payment between the reference date and the appeal deadline (June 18 to September 12) such as through naturalization, visa status change, or obtaining National Health Insurance coverage, among other reasons.

If eligible to file an appeal, you must submit an appeal form and supporting documents between July 21 and September 12, either in person at [eup/myeon/dong community service center](#) (offline), or online via the [e-People portal](#).

How to File an Appeal

- **Filing Period : July 21–September 12**
- **Where to File : e-People portal (Online) or [eup/myeon/dong community service center](#) (Offline)**
- **Supporting Documents : Vary depending on your circumstances (please contact the call center for more information)**
- Proof of identity (e.g., Certificate of Domestic Residence, Certificate of Alien Registration, or Certificate of Overseas Korean Registration)
- Certificate of National Health Insurance Eligibility or Certificate of Insurance Enrollment and Termination
- Documents proving a “family relationship under the Civil Act” (e.g., Certificate of Family Relations, Birth Certificate, Marriage Certificate, or Death Certificate of the applicant or their family members)

For the recovery of all citizens' livelihoods,
customized support is provided
based on income in phases.

1st Round

KRW 150,000 per person to all citizens
KRW 300,000 for lower-income families,
KRW 400,000 for basic livelihood support recipients

- **Non-metropolitan areas** (excluding Seoul, Incheon, Gyeonggi, & rural depopulation areas): Additional KRW 30,000 per person
- **Rural depopulation areas** (84 cities/counties): Additional KRW 50,000 per person

2nd Round

Additional payment of KRW 100,000 per person to 90% of citizens
(eligibility determined based on health insurance premiums)

Who Can Apply



Individual Applications for Individual Support!

Those born before December 31, 2006: Individual application and support

For minors: the head of household on resident registration must apply and receive the support on their behalf (gift certificates, prepaid cards, etc.).

- If the minor is the head of household and there are no adult members on the resident registration, they can apply directly.

Application and Issuance



1st Round

July 21 (Mon) -
September 12 (Fri)

2nd Round

September 22 (Mon) -
October 31 (Fri)

During the first week of application, the day-of-week system applies based on the last digit of the birth year: Last digit 1·6→Mon, 2·7→Tue, 3·8→Wed, 4·9→Thu, 5·0→Fri

Online: All application on weekends available, **Offline:** Weekends not available

Period of Use



Both 1st and 2nd Rounds:
Use by November 30 (Sun)

Unused amounts will expire automatically and cannot be refunded.

Timeline and Application Method

**For advanced applications, notifications will be sent
two days before the application date (July 21) on July 19.**
