The National Health Insurance Service provides age-appropriate health checkups (including physical measurements, health education, developmental assessment, and counseling) for infants and young children from 14 days to 71 months old. These checkups consistently monitor growth and developmental milestones to help protect children's health.

## **Overview**

- Eligibility: Infants and young children under the age of 6 (Health insurance subscribers and medical aid beneficiaries)
- Goal: Monitor the infant and young child's growth and developmental milestones
- Type: General infant health checkup (including developmental screening) and dental checkups
- Out-of-pocket: Free of charge if the checkup is within the designated period
- \*\* The infant and young child health checkup result notifications may be used for submission to daycare centers and kindergartens.
